# **REVISED FISCAL YEAR 2020 OPERATING BUDGET:**

Discussion was held at the Committee of the Whole, no further discussion was held.

<u>Member Restrepo moved</u>, Member Rosen seconded, that the Board of Trustees approves the revised FY 2020 operating budget and proposed allocation of projected operational net income to the SSIF, and the revised FY 2020 Auxiliary Fund budget and authorizes the following:

- Final audited, unallocated FY19 operational net income be allocated to Contingency and \$650,000 from final audited Auxiliary net income be allocated to debt service;
- Up to \$500,000 be re-allocated from unobligated funding within the Capital Equipment allocation to the Capital Improvements allocation for remaining Mitchell Hall construction costs;
- The President to allocate additional general and auxiliary fund operating and instructional expenses commensurate with enrollments and related revenues in excess of amounts included in the revised FY 2020 budget provided the operating budget remains balanced; and
- The President to re-allocate funds between existing operational reserve allocations, if necessary, that best reflect their ultimate proposed use.

The College is an awardee of Achieving the Dream's Leader College of Distinction Designation, the second year that ATD has offered this designation. The Designation is the highest ongoing recognition for achievement. Leader Colleges of Distinction play important roles in accelerating adoption of effective practices with the ATD network and across higher education.

# • The Columbus Foundation Celebrates Columbus' National Number Ones – February 13, 2019

The College will be celebrated by the Columbus Foundation for being awarded the Leah Meyer Austin Award from Achieving the Dream (ATD) in February 2019. ATD gives this award annually to a college that employs a holistic approach to reducing equity gaps between student groups and increasing success for all. The award recognizes institutional strength, aligned policies and procedures, a student-focused culture, and notable increases in student outcomes.

The Columbus Foundation's 2020 National Number Ones cohort is made up of individual community leaders and organizations who, during the past year, have been recognized by their industry peers for their outstanding contributions to their fields.

# • Columbus State Community Partners (CSCP)

CSCP, an affiliate of the College that will carry out real estate activities, held their first meeting on January 9<sup>th</sup>, 2020. The CSCP board is Poe Timmons, Executive VP & Chief Financial Officer, Jeni's Splendid Ice Creams LLC; Dr. Donna Goss, Director of Development, City of Dublin, Ohio; Rick Ritzler, Chief Talent Officer, g20; Dr. Rich Rosen, Founder, Indigo Strategies; Bob Tannous, Managing Partner, Porter, Wright, Morris & Arthur LLP; L'Quentus Thomas, Managing Director, Stonehenge Capital Company; and Skip Weiler, President, The Robert Weiler Company. # • The Office of Talent Strategy at Columbus State

The Office of Talent Strategy is a new function of the College that will serve as the regional convener for workforce solutions in partnership with One Columbus, Central Ohio's economic development organization. Cheryl Hay, formerly of Jobs Ohio, will serve as the Executive Director. Services of the office include:

- Provide talent solutions and consultative guidance, leveraging all regional assets.
- Enable experimentation and innovation.
- Convene K12 and university partners around a regional strategy.
- Make it easy for employers to access services and solutions and learn from each other.
- Measure results; document and disseminate best practices.
- Inform public policy through data-driven practices and measurable results.
- Communicate regionally, statewide, and nationally.

# • College Promise

Dr. Rebecca Butler shared that the College and Councilmember Shannon Hardin from the City of Columbus are in conversation regarding College Promise Programs. Key components of nationwide College Promise Programs include:

- Clear and simple guarantee that if students meet basic criteria, finances won't be a barrier to obtaining post-secondary education
- Will be available to both part-time and full-time students

There are over 150 cities who have implemented College Promise Programs, Dallas, Texas, and Kalamazoo, Michigan are among the cities demonstrating best practices along with the State of Tennessee. The City of Columbus is in early phases of research and benchmarking; the College will continue to participate in conversations and research with the City.

# • Student Information System Update

Drs. Babb and Anderson shared updates and information regarding the College's pursuit to replace the core suite of enterprise student and employee applications. The College's current student information system technology is outdated.
