#### PRESIDENT'S REPORT:

President Harrison reported on the following items:

## 1. Staff Employees of the Month

Full-time Staff Employees of the Month for February and March 2014 were Jessica Allen, Representative, Telephone Information Center and Stacey Raymond, Lab Coordinator, Early Childhood Development and Education, Human Services, respectively.

Part-time Staff Employees of the Month for February and March 2014 were Toshi Pearson, Representative, Telephone Information Center and Sheri Harrington, Advisor, Advising and Student Support Services, respectively.

## 2. Trustee Dianne Radigan Honored

Congratulations to Trustee Dianne Radigan who received the Cardinal Health Founder's Award. This award is given to exemplary employees who live the core values of Cardinal Health each day, and are chosen by Cardinal Health employees. There are 30,000 Cardinal Health employees world-wide and only four of these awards are given yearly.

## 3. Complete College Ohio Task Force

The Ohio Board of Regents is requiring that each college, university, and career technical center in Ohio adopt a Completion Plan by the end of this fiscal year.

The Completion Plan is to include:

- Specific, measureable goals
- A mix of tactics and strategies
- Metrics
- Must be consistent with the institution's mission and strategic priorities

The College Completion Plan structure mirrors our current student success plans and strategic planning efforts.

## 4. Governance Institute on Student Success (GISS) Update

The 2014 Institute is designed to meet the needs of new and returning college trustees and presidents, focusing on how the Ohio Board of Regents data can be used to inform colleges' completion plans, and featuring updated board self-assessments, and case studies.

## 5. New Brand Identity – Beyond Measure

The College started investigating a new branding several months ago. Dr. Harrison showed one of the new commercials that will air over the next several months advertising our new branding.

## 6. The Central Ohio Compact

The Compact has become an organizing framework for a significant amount of the completion, access, workforce, and affordability work in the region. The initial Pathways to Prosperity Partners were JPMorgan Chase, Ohio Business Roundtable, Battelle, and the Educational Service Center. Last summer/fall when Columbus City Schools was a focal point for us and the business community, Dr. Harrison began

working with American Electric Power (AEP). The program they are branding is "Credits Count" and they have provided a \$5 million grant for Columbus State to build those principles into five Columbus City high schools over a five year period. West High School will be the first school this coming fall. Columbus State will have advisors and faculty working shoulder-to-shoulder with the teachers, counselors, families, and the community. AEP serves 11 states and they want Columbus State to help them implement this in all of their service areas.

In the fall, the state issued their first round of "Straight A" grants, and Columbus State is the higher education partner in two of the largest grants from the first round. One is with Marysville and Honda, and Marysville City Schools is the fiscal agent. Marysville is repurposing its middle school building into an advanced manufacturing academy working closely with Honda. The second "Straight A" grant is Pathways to Prosperity, and Reynoldsburg City Schools is the fiscal agent for this grant.

Columbus State is working with these districts on pathways to associate degree programs in business logistics, healthcare, advanced manufacturing, and information technology.

As a result of the AEP work, Nationwide Children's approached Columbus State to update us on their Healthy Neighborhoods/Healthy Families initiatives. These initiatives have focused on the three zip codes adjacent to Nationwide Children's to help improve the quality of life in the neighborhood. Nationwide Children's has been heavily involved with area issues pertaining to housing, childhood nutrition, obesity, and early childhood education. They would like for Columbus State to be

their employment partner, and specifically they would like to have more of the people that live near the hospital, work at the hospital.

In January JPMorgan Chase internationally announced a \$250 million program called "New Skills at Work," and it aligns directly with the ongoing objectives of the Central Ohio Compact.

## 7. CSCC and Ohio University Partnership

Ohio University broke ground for their Dublin extension campus. Columbus State will partner with them, and the initial programs are likely to include the associate degree in Surgical Technology and Health Information Management to supplement our current Dublin offerings.
