COLLEGE'S MISSION AND VISION STATEMENTS:

Dr. Richard D. Rosen read the College's Mission and Vision Statements.

OPENING REMARKS FROM VICE-CHAIR RESTREPO:

Vice-Chair Restrepo shared that at the request of Congressman Pat Tiberi, Chair, of the U.S. Joint Economic Committee, President Harrison, along with three other speakers, testified at a Congressional hearing presenting their view points and suggestions for the hearing on "A Record Six Million U.S. Job Vacancies: Reasons and Remedies." Vice-Chair Restrepo noted that it was appropriate recognition for President Harrison as a strong leader in workforce planning and development, and raises the profile and the brand of Columbus State as an innovative solution provider for a huge national problem.

OPENING REMARKS FROM PRESIDENT HARRISON:

President Harrison used this time to receive the Apple Distinguished Program award, and to present brief updates and demonstrations to the Board of Trustees from staff and faculty members who are doing exemplary work with iBooks and other digital contents.

- Mr. Kelly Gardner, Director of Higher Education Sales, presented President Harrison with a
 plaque and banner honoring Columbus State as one of twenty Apple Distinguished
 Programs world-wide. Columbus State received the award in recognition of exemplary
 performance in the areas of innovation, leadership, and excellence in teaching and learning.
- Jason LaMar, Supervisor, Instructional Technology and Innovations was an Apple
 Distinguished Educator last year. He was recognized by Secretary of State Husted for the
 iBook he created on Ohio Pathway to Presidency. He has also developed an iBook telling
 the Columbus State story, and Apple is using on their website. Board members received
 iPads to view as Mr. LaMar showcased the iBook.
- Eric Kenz, Assistant Professor, Biological and Physical Sciences is an Apple Distinguished Educator and demonstrated his iBook project.
- Todd Warner, Executive in Residence, Workforce Innovation explained that Columbus State was selected as one of six community colleges identified to help implement the Apple Swift mobile training program. The kick-start program is an eight week program that will launch in September. Students entering the program will have little to no development experience and, based on the curriculum of the course, they can complete the course with the knowledge of three working applications.
