CALL TO ORDER:

The regularly scheduled meeting of the Board of Trustees of the Columbus State Community College was held on Thursday, September 21, in the Workforce Development Center, 315 Cleveland Avenue, Room 404. The meeting was called to order by Chairperson Dianne A. Radigan at 6:02 p.m.

COLLEGE'S MISSION AND VISION STATEMENTS:

Trustee Timmons read the College's Mission and Vision Statements.

OPENING REMARKS FROM CHAIR RADIGAN:

Chair Radigan stated that a critical part of our role as Trustees of the College is to support the President and together establish goals for Columbus State Community College, execute them, and then assess progress toward those goals.

Guided by our vision, mission and values as well as our strategic plan for the College, the goals for 2016-17 again centered on three key areas:

- Achieving student success.
- Strengthening the capacity of the institution.
- Advancing strategic partnerships.

The College made strategic and significant strides in each of these areas under President Harrison's leadership. Chair Radigan highlighted the following examples in each area:

Achieving Student Success

- In May 2016, we had our largest graduating class in the College's history with autumn to spring retention improving for all students and significantly improving for students of color.
- We continued to expand one of the key contributors of student success, with orientation reaching 1700 students in 2016.
- We developed a comprehensive career and academic pathway work plan to further help our students define, and then achieve their personal goals.

• Strengthening the Capacity of the Institution

- We began the development of a 10+ year vision and planning process for facility needs which will help us continue to be most responsive to the needs of our community and our students, and will guide our State Capital requests, as well as private funding strategies.
- We launched a Capital Campaign to support the School of Hospitality Management and Culinary Arts, diversified and increased restricted and unrestricted giving, and strengthened the Foundation Board.
- o We established and executed risk management as a routine process for the College.

Advancing Strategic Partnerships

- We are clearly a leader in workforce development in Central Ohio through the College's involvement with the Creative Campus, our role to deliberately align the Central Ohio Compact with workforce needs, and by establishing a Workforce Advisory Council of corporate HR executives to advise the College on emerging workforce needs and develop a regional strategy.
- We are partnering with Honda to develop a pipeline of electro-mechanical engineering graduates, with the Insurance Industry Resource Council to help meet the need for 26,000 jobs in this industry, and with Amazon Web Services to address the growing needs in Cloud technologies.
- We secured an \$11 ½ million dollar Investing in Innovation Grant from the U.S.
 Department of Education. We are convening human service providers as part of that, and pilot testing student-centered strategies to address non-academic barriers.
- We continued legislative advocacy for tuition flexibility, testifying before both House and Senate Higher Education Finance Committees.

Acknowledgment for this good work has been significant and recognized by many organizations. Columbus State is the only community college in America to be recognized as a Leader College by Achieving the Dream; one of 30 colleges to participate in the Gates Foundation Pathways work; and we were asked to participate as one of 20 colleges in the Lumina funded Right Signals Initiative. We are the only community college with all three of these recognitions. Columbus State is also a top-tier leader in the National Science Foundation's Advanced Technological Education program.

These examples are just that, examples of so much more that is taking shape each and every day at Columbus State. We are grateful to Dr. Harrison for his vision, leadership, tireless commitment, and compassion for the needs of our students. We are grateful for the leadership team, the faculty and administrative professionals who are so passionate about this work and among the best in the nation.

I believe I speak for all Trustees when I say we are proud and humbled to be part of this organization and we see a very bright horizon as we move forward with our goals for 2017-18 and beyond.

• Child Development Associate (CDA) Initiative 2020

Dr. Tom Habegger, Dean, Health and Human Services, and Ms. Melanie Adams, Associate Professor, Human Services, explained the CDA initiative. The CDA is a national credential and a gateway credential to an ECDE degree. By 2020, childcare providers must hire assistant teachers that hold at least a CDA credential. By 2024, these early childhood practitioners must possess an associate of applied science degree in early childhood education. For the Columbus State early childhood students, obtaining the CDA is the first semester of their early childhood degree. After the first semester our students have the classes they need to sit for the national credential. Because of this change, the early childhood development enrollment is up 43% this semester, approximately 675 more students.

The City of Columbus requested that Columbus State partner with them to offer a pilot program. The City awarded Columbus State a \$90,000 grant to support two cohorts this past winter. The courses were held at the Reeb and Saint Stephens Centers with 48 participants and a completion rate of 94%. The course was 12 weeks in duration. The City was pleased with the results and awarded the College an additional \$200,000 grant that will support four additional cohorts (96 students) this autumn semester with one in the Somalian community.

Ms. Adams presented information on a Columbus State ECDE/CDA Wonder School proposed partnership. The partnership would include Columbus State, the Columbus Museum of Art and the Childhood League.
